1. EMAIL IQ™ END USER LICENSE AGREEMENT

The terms and conditions in this agreement (the "Agreement") will govern you (the "User") access to email iQ™ ("doing business as Kinexus Internet Ltd") Services and your use of the data you obtain by use of the Services. Kinexus grants to the User a non-exclusive right during the term of this Agreement to use the Services pursuant to the terms and conditions set out herein. Your use of the Services confers no title or ownership in the Services. All ownership rights remain in Kinexus or its third party suppliers, as the case may be.

2. SERVICES TO BE RENDERED AND DELIVERY OF SERVICES

Kinexus offers its services on an "as is" basis. Through the "Services", Kinexus provides marketing tools, information, information management and storage and support. Users can create and send email campaigns using the tools to distribute content supplied by the User to email addresses also supplied by the User. The User acknowledges that Kinexus does not create any content and that Kinexus is not the author or the publisher of any campaign. The User further acknowledges that Kinexus does not rent or sell email lists. Kinexus reserves the right, but is not obligated to, review and approve any content posted by Users. Kinexus disclaims all copyright and other rights in such content and all responsibility for them. Kinexus retains the right to cancel and delete any campaign violating its Usage Rules, see below.

By permitting direct email campaigns, Kinexus makes no warranties or representations of any kind as to the accuracy of the content or suitability of the subject matter. Kinexus specifically disclaims liability for direct, consequential or incidental damages arising from such campaigns. By posting an email campaign from Kinexus, User warrants that the content is true, and that User will indemnify Kinexus against any and all, direct, indirect or consequential claims and alleged claims that may arise from User's use of the Services. User will also indemnify Kinexus in the event that Kinexus shares the User's name with third parties for violations of Usage Rules. By using Kinexus Services, the User is giving Kinexus permission to copy and/or store User content, contact lists and other information. Kinexus will not use the User content, contact lists or other User information for any purpose that violates its privacy statement located on its website at http://www.emailig.com/policies.htm As part of the Services, Kinexus may notify User, at the email address provided to Kinexus during User registration or as updated at any future time by the User, when the User campaign has been sent. Kinexus will use reasonable efforts to ensure posting of the User campaign at the scheduled time. However, Kinexus reserves the right to alter the time and date of delivery of the campaign and the delivery of the results without prior notification to the User of such a change. Kinexus also reserves the right to limit the number of emails that can be sent, per campaign, at any time. For every e-mail message sent in connection with the Services, Customer acknowledges and agrees that the Services shall automatically add an identifying footer stating "Powered by email iQTM" or

No agency, partnership, joint venture, or employment is created as a result of this Agreement, and Customer does not have any authority of any kind to bind Kinexus in any respect whatsoever.

3. ELIGIBILITY

The Services are available to individuals who are eighteen (18) years of age or older as well as companies, corporations and other organisations who can form legally binding contracts under applicable law. If you do not qualify, please do not attempt to use the Services. You will provide true, accurate, current information about yourself as requested by the sign up, registration or billing process. Kinexus may refuse to offer the Services to any person and may change the criteria for eligibility, at any time, in its sole discretion. Kinexus retains the right to terminate your account and your rights to use the Services if there are reasonable grounds to believe that any data you provide is or becomes untrue, inaccurate, not current or incomplete.

4. ACCOUNT PASSWORD AND SECURITY

The User is responsible for maintaining confidentiality of its user name and password. Furthermore, the User is entirely responsible for any and all activities that occur under its user name and password. The User is to immediately notify Kinexus of any unauthorised use of the account or any breach of security.

7. USAGE RULES

- (ii) With regard to email campaigns, the User specifically agrees not to use the Services:
- (iii) To send email to any party who has not given their permission to receive email from the User. User understands the repercussions if a complaint or complaints are received. See Kinexus's Anti-Spam policy at http://www.emailig.com
- (iv) For any unlawful purposes.
- (v) To harass, threaten, embarrass or cause distress, unwanted attention or discomfort to a person or entity.
- (vi) To send content or links to content that contains nudity or sex pornography material of any kind to individuals under age 18, or to anyone on lists that are not limited to people age 18 or older.
- (vii) To send, submit or publish any defamatory, inaccurate, abusive, obscene, profane, or threatening material which is racially or ethnically offensive or which infringes upon the right of any third party, as determined by Kinexus.
- (viii) To send content that contains links to web pages that contains nudity, sex, pornography, tasteless images, foul language, hate propaganda, anything illegal, illegal software, serial numbers for unlocking software, mail fraud, pyramid schemes or is otherwise insulting to another person(s).
- (ix) To encourage the use of any controlled substance, transmission of material, information or software in violation of any local, national or international laws and treaties.
- (x) To impersonate any person, including but not limited to, an official of Kinexus or an information provider, or communicate under a false name or a name that the User is not entitled or authorised to use.
- (xi) To upload, post or reproduce in any manner any material protected by copyright without the permission of the copyright owner. To send content that promotes or provides instructional information about illegal activities, or promoting physical harm or injury against any group or individual.

The User agrees not to directly or indirectly reverse engineer, decompile, disassemble, or otherwise attempt to discover source code, object code, or underlying structure, ideas, or algorithms of, or found at or through the Services of any software, documentation, or data related to the Services. In the event that the User violates one of the above usage rules, or for any other reason deemed appropriate by Kinexus, Kinexus reserves the right to suspend or terminate, with or without notice, access to the User's account and all related data. Kinexus also reserves the right to modify

Kinexus has no responsibility or liability for the deletion or failure to store any messages, content or other information maintained or transmitted through the Services. At any time Kinexus may determine that User information can no longer be stored by Kinexus or deem User information to be inappropriate and remove it from its databases with or without notice to the User. If the User does not log into its account for more than 90 days, the account will become inactive. When an account is inactive, at Kinexus's sole discretion, Kinexus will notify the User by email. Inactive accounts have 30 days to become active after notification or the account and its data may be permanently removed from the Kinexus databases.
